Guest/Visitor Waiver/Release

The object of this organization shall be the encouragement and promotion of organized shotgun, rifle, pistol, and archery shooting with a view toward a better knowledge of the safe handling and proper care of firearms, as well as improved marksmanship. It shall be our further object to provide fellowship through mutual interest, and to encourage good sportsmanship among its members.

In consideration for my being permitted to participate in the activities of Lisbon Fish & Game Assn. (LF&GA), I agree to the following Waiver and Release. I acknowledge that I have read and do understand the **Club Safety Rules** and that I will abide by them. I acknowledge that shooting has inherent risks, hazards and dangers that cannot be completely eliminated. I understand that these include but are not limited to:

- A. The risk of handling firearms and being near others that have firearms in their possession.
- B. The risk of personal injury and/or damage to personal property from shooting events.
- C. The risk of personal injury from the physical requirements of shooting events.
- D. The risk of ear damage from noise.
- E. The risk of possible eye damage.

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss any questions with an officer of LF&GA. I understand that these activities may require good physical condition and a degree of skill and knowledge. I believe that I have the physical conditioning and degree of skill and knowledge needed for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. I am voluntarily using the services of LF&GA with full knowledge of the inherent risks, hazards and dangers involved and hereby assume and accept any and all risk of injury, paralysis or death.

Last, I, for myself, my heirs, successors, executors, and subrogates, hereby and knowingly and intentionally waive and release, indemnify and hold harmless LF&GA staff, personal, all officers, agents, employees, and all volunteers from and against claims, actions, cause of action, liabilities, suites and expenses (including responsible attorney's fees) which are related to, arise out of, or are in any connected with any participation in any activity including, but not limited to, negligence of any kind in nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis or death to me or my property, as services, animals or equipment, whether such damage, loss injury, paralysis or death is a result of negligence of LF&GA or course designs or from some other cause. I, for myself, my heirs, successors, executors, and subrogates, further agree not to sue LF&GA, any officers, directors, agents, employees or volunteers as a result of injury, paralysis or death suffered in connections with my use and participation in any activity connected with LF&GA.

I, as a guest/visitor of LF&GA, do acknowledge that I am on the property voluntarily and that I must be accompanied at all times by a member sponsor in good standing.
